2. To continue to maintain the animal described above with proper feed, pasture feed, pasture, vaccination, worming and general health care and shall not at any time make the 4-H Llama and Alpaca Project Member responsible for monetary costs for these items.
3. To pay all veterinary bills emergency or otherwise, originating from the animal described above.
4. To make the animal available to the Project Member (provided the Project Member is in “Good Standing Status” in the 4-H Llama and Alpaca Project) at the owner’s convenience for project meetings during the 4-H year project year and for the Coshocton County Fair.
5. The Animal Owner shall at all times maintain his/her right to use the animal for showing/pleasure or breeding purposes.
